

History of the POW Research Network Japan

<2002>

- 2002/3/31 The POW Research Network Japan (hereinafter, “the Network”) was established, and held the 1st Annual Meeting in Tokyo.
- 2002/04/11-16 Former Australian POWs, Messrs. Neil MacPherson and Owen Heron came to Japan with their sons. They visited the Commonwealth War Cemetery in Yokohama, and the site of Senryu Coal Mine Camp (Fukuoka #24, Nagasaki Pref.).
Note: As a general rule, the Network makes it a rule to have some members accompany a visitor(s) from overseas strictly on a voluntary basis. In order to avoid redundancy of the descriptions, however, this will not be mentioned hereinafter.
- 2002/4/17 With the corporation of the Network, a documentary “212 mai no Ninshikihyo – Kensho, Eibun Horyo no Shokon to Sengo Hosho – Verification of the 212 dog tags, former British POWs’ scars and the postwar compensation” was broadcast in the Kansai District.
- 2002/5/13 Mrs. Fuyuko Nishisato, a Network member, published a book “Seibutsusen Butai 731, Amerika ga menzaishita Nihongun no Senso Hanzai – The 731st Biological Warfare Unit of the Japanese Army, whose war crime was acquitted by the US.” A publication party was held at the Foreign Correspondents’ Club of Japan in Tokyo.
- 2002/7/13-14 Mr. John Glusman, son of a former American POW medical officer, came to Japan to visit the sites of Tsumori Camp (Osaka #3, Osaka Pref.) and the POW Hospital in Kobe. A get-together meeting was held at the Kobe Gakusei Seinen (Students and young people’s) Center. Some Network members accompanied him.
- 2002/9/4-10 A former Australian POW, Mr. Jack Thorpe and his son came to Japan, and visited the site of Tadakuma Coal Mine Camp (Fukuoka #22, Fukuoka Pref.), Kure City where he had been stationed during the occupation period, and the Commonwealth War Cemetery in Yokohama.
- 2002/10/13-14 The 2nd Annual Meeting of the Network was held in Joetsu City, Naoetsu Camp (Tokyo #4, Niigata Pref.) had been located. The Network members visited the Memorial Peace Park, Monuments, and the Museum built at the camp site.
- 2002/10/14 With the cooperation of the Network, “Kobe Harbor field work” was conducted by a research group in Kobe.

- 2003/3/19 Mrs. Yukako Ibuki, a Network member, and others translated a book “My Hitch in Hell, The Bataan Death March” by Dr. Lester Tenney, and published it under the Japanese title of “Bataan Tohi Michinori no saki.” Dr. and Mrs. Tenney attended a party celebrating the publication of the books.
- 2003/5/21-25 Five Network members attended the 59th Annual Assembly of the American Defenders of Bataan and Corregidor (ADBC) in Albuquerque, New Mexico.
- 2003/7/? Mr. Shimpei Ishii, a Network member, translated a book “The Wages of Guilt, Memories of War in Germany and Japan” by Ian Buruma, and published it under the Japanese title of “Senso no kioku, Nihonjin to Doitsuujin.”
- 2003/8/15 Mrs. Fuyuko Nishisato, a Network member, translated a book “Unit 731 Japanese Army’s Secret of Secrets” by Peter Williams and David Wallace, and published it under the Japanese title of “731 Butai no Seibutsu heiki to Amerika, Baio Tero no Keifu.”

2003/11/2-3 The 3rd Annual Meeting of the Network took place in Tokyo. Mr. Yuichi Hatto, a former IJA Sgt. worked at Omori (Tokyo Main) Camp, and Mr. Tokio Tobita, a former IJA Sgt. worked at Shingawa Hospital lectured on their wartime experiences, respectively. Thereafter, the members visited the sites of Omori Camp, Shinagawa Hospital, Sumidagawa Camp (Tokyo #10), and Bunka (Culture) Camp.

- 2004/3/13 Ms. Noriko Hirata, a Network member, translated a book "Summer will come again" by John Lane, an Australian POW in WWII, and published it under the Japanese title of "Natsu wa futatabi yattekuru." Mr. and Mrs. Lane came to Japan to visit the site of Kobe Camp (Osaka #2), and attended a publication ceremony.
- 2004/3/15 Mr. Grant McLachlan, grandson of a former British POW, came to Japan from NZ to produce a movie. He visited the sites of Mitsushima Camp (Tokyo #12, Ngano Pref.) and Kanose Camp (Tokyo #16, Niigata Pref.), and interviewed the local people.
- 2004/4/6 A study meeting on the "POW Bill" was held at No. 2 Assembly Hall of the House of Representatives by PMs Eiko Ishige, Asuma Konno, and the interested members of the Network, including Mr. Toshiaki Manabe, a lawyer. M. Manabe lectured on the agenda.
- 2004/4/9-18 Former Australian POWs, Messrs. Neil MacPherson, Jack Boon, and Jack Simmonds and their families, a total of 6 persons came to Japan to visit the Commonwealth Cemetery in Yokohama, and the sites of Takefu Camp (Osaka #7, Fukui Pref.), Saganoseki Camp (Fukuoka #13, Oita Pref.), Senryu Coal Mine Camp (Fukuoka #24, Nagasaki Pref.), and Mitsui Miike Coal Mine Camp (Fukuoka #17, Fukuoka Pref.), respectively.
- 2004/5/1 Professor Aiko Utsumi, a Network member, published a book entitled "*Sugamo Purizon - Sempan tachi no Heiwa undo*; The Sugamo Prison and Peace movements by war criminals."
- 2004/5/3 The POWRNJ set up a website on the Internet, and published a list of some 1,700 Allied POWs, whose remains are buried at the Commonwealth War Cemetery in Yokohama.
- 2004/5/3 Study meeting: Former military personnel, Mr. Masao Hirakubo, Mr. Tatsuo Morohoshi and Mr. sadao Oba, talked about their war experience.
- 2004/5/4 The Japan Times carried an article entitled "Past and Present" by Ms. Satoko Kogure, a Network member, on the list of the deceased Allied POWs prepared by the Network, and the former Australian POWs visited Japan in April this year.
- 2004/6/? The Japan Times carried an article entitled "Causality of War" by Ms. Satoko Kogure, a Network member, on the mistreatments of the Iraq POWs.
- 2004/7/26 A symposium was held by the Yokohama Bar Association's Special Committee for investigating the B & C classes war criminal trails to commemorate the publication of a book "Hotei no Seijoki, BC kyu Sempan Yokohama Saiban no Kiroku - The Stars & Stripes in the Military tribunal, Records of the Yokohama Military tribunal for the B & C classes war criminals." Mr. Toshiaki Manabe, the Special Committee, is also a Network member.
- 2004/8/4-10 Mr. David Barrett, a former Australian POW, forced to labor at the Burma-Thailand Railway, and his family came to Japan. They visited the Commonwealth Cemetery in Yokohama, Hiroshima, Kurashiki, and other places in the country.

- 2004/8/9 Mrs. Taeko Sasamoto, with the help of Mrs. Yoshiko Tamura for interviewing foreigners (both are the Network members), published a book “Rengogun Horyo no Bohimei – The Epitaph of the Allied POWs.”
- 2004/8/10–16 Former POWs, Messrs. George Dunbar, Eric Robinson, John Phillips, Robert Pogson and their families, a total of 8 persons came to Japan to visit the Commonwealth Cemetery in Yokohama and the site of Ikuno Camp (Osaka #4, Hyogo Pref.).
- 2004/8/13 A Network member, Mrs. Taeko Sasamoto’s activities named “Hakkutsu sareta Rengogun Horyo no Kiroku – Unearthed records on the Allied POWs” was broadcast on the NHK program of “Today’s World.”
- 2004/8/15 Messrs. Toru Fukubayashi and Yozo Kudo (Network members) and Mr. Yoshishige Okuzumi published their joint work “Horyo shuyosho hokyu sakusen: B29 butai saigo no sakusen” (Airdrop Operations of the POW relief supplies – the last missions flown by the B-29 Units) at their own expense.
- 2004/9/12–20 Mr. Grant McLachlan, grandson of a former British POW, came from NZ to produce a movie for the second time. He visited the sites of Mitsushima Camp (Tokyo #12, Nagano Pref.) and Kanose Camp (Tokyo #16, Niigata Pref.). Thereafter, interviewed the Yokohama Bar Association.
- 2004/10/? A former British POW, Mr. William Rose came to Japan, and visited the site of Mitsushima Camp and other places in the country.
- 2004/10/30–31 The 4th Annual Meeting of the Network was held in Miyazu City, Kyoto Pref. The participants visited the sites of Oeyama Camp (Osaka #3, Kyoto Pref.) and the Chinese/Koreans Camps.
- 2004/11/2 The Japan Times carried an article entitled “Justice reaches the dead-end” by Ms. Satoko Kogure, a Network member, on Mitsushima Camp.
- 2004/12/28 The Network additionally released on its website a list of all Allied POWs who had deceased in Japan during WWII.

- 2005/1/?–2/? The Mainichi Dailies, the Japan Times, Kahoku Shimpō, Okinawa Shimpō, the Courier Mail of Australia, and the Daily Telegraph of England carried an article that the Network had released a list of all Allied POWs deceased in Japan during WWII on its website. The Network received over 100 email inquiries from all over the world.
- 2005/3/? Prof. Gregory Hadley, a Network member, completed his thesis to prove “The POW massacre incident in Aikawa, Sado Island” by James MacKay had appeared on “Betrayals in High Place” was a complete fabrication. His thesis was introduced on the Sankei Dailies, Shikoku Shimbun, Niigatta Nippo, and other newspapers.
- 2005/3/? Mr. Masanori Suzuki, a Network member, translated a book “Snaring the other tiger” by Ian Ward, and published it under the Japanese title of “Shogun wa naze korosaretaka, Goshu Senso Saiban Nishimura Takuma Chujo no Higeiki. “The Australian War Criminal Trail, Tragedy of Lt. Gen. Takuma Nishimura.”
- 2005/3/19 Study Meeting: Mr. Masanori Suzuki lectured on his work “Shogun wa naze korosaretaka – Snaring the other tiger” and Mr. Stanley Guy, a British writer on “A British POW detained in Koyagi Camp, Nagasaki Pref.”, respectively.
- 2005/3/22 The Network received the Australian–Japanese Foundation Award, and the presentation ceremony was held at the Australian Embassy.

- 2005/3/26 Ms. Pek Iona, a Korean freelance TV director and granddaughter of an IJA Lt. General Hong Sa-ik, executed in the PI on a charge of the conduct of his prison guards while he was POW Camp Commandant, visited Japan to interview the General's former subordinates, Korean war criminals, and Japanese researchers conducting survey on the General. Some Network members assisted her with the interviews.
- 2005/3/27 A former British POW, Mr. David Russel and his family came to Japan, and visited the Commonwealth Cemetery in Yokohama and the site of Ikuno Camp (Osaka #4, Hyogo Pref.).
- 2005/3/28 A former American POW, Mr. Oscar Leonard and his family came to Japan, and visited the site of Tokyo #2 Camp in Kawasaki, the old NKK Ohgi Machi factory and the Commonwealth Cemetery in Yokohama.
- 2005/4/4-10 Mr. Pat Flanagan, son of a former Australian POW, and his family came to Japan, and visited the site of Ohama Camp (Hiroshima #10, Yamaguchi Pref.) and the Commonwealth Cemetery in Yokohama.
- 2005/4/10 Mr. and Mrs. Hopkins, bereaved family members of a former British POW, came to Japan to visit the Commonwealth Cemetery in Yokohama.
- 2005/4/? Prof. Aiko Utsumi, a Network member, published a book "Nihongun no Horyo Seisaku - The Japanese Military's policies on POWs."
- 2005/5/22 The Mainich Dailies, based on a photo found at the NARA by Mr. Toru Fukubayashi, a Network member, carried an article on "Chubu Kempei tai Jiken Shoko Shashin - A photo used as an evidence of the Chubu Military Police incident."
- 2005/6/7-11 A former British POW, Mr. Stanley Topham and his son came to Japan and visited the Commonwealth Cemetery in Yokohama, and the site of Mitsushima Camp (Tokyo #12, Nagano Pref.). The BBC broadcast a program about their visit on August 15.
- 2005/8/2-11 Thru the educational program of the Imperial War Museum in the UK, 33 students of the Cheney High School in Oxford City visited Japan. They paid calls on the Commonwealth Cemetery in Yokohama, Yasukuni Shrine in Tokyo, and visited Hiroshima and Tenryu Village in Nagano Pref., where they had a get-together meeting with a local high school students. The Network assisted the visitors with their tour in the country, and the debate carried on in English at Yokohama Eiwa Women's Seminary.
- 2005/8/12 A weekly magazine Friday carried a translation of Prof. Gregory Hadley's thesis "Verification, the Imperial Army's POWs, a fabricated Sado Island massacre incident developed a life of its own in the Internet." The translation was done by Mr. Masanori Suzuki, a Network member.
- 2005/8/15 The 60th Annual Memorial Service was held at the Commonwealth Cemetery in Yokohama.
- 2005/8/17 A former B-29 crewmember and POW, Mr. Martin Zapt came to Japan, and visited Masuda City in Shimane Pref., and Mukaishima Camp (Hiroshima #4, Hiroshima Pref.). TV Asahi broadcast a documentary on his visit "Hiroshima wo saisho ni mita Beihei - a GI who was the first to witness Hiroshima" on September 13.
- 2005/9/23-25 The 5th Annual Meeting of the Network was held in Tenryu Village, Nagano Pref. The participants visited Hiraoka Dam, site of Mitsushima Camp (Tokyo #12), and the camps for the Chinese and Koreans forced to come and work in Japan, and their cemetery.

- 2005/11/? Mr. and Mrs. Booth, bereaved family members of a former British POW, came to Japan and visited the site of Ohama Camp (Hiroshima #9, Yamaguchi Pref.) and the Commonwealth Cemetery in Yokohama.
- 2005/11/28-29 To produce a documentary on a hell ship the Lisbon Maru, the staff members of Phoenix TV in Hong Kong came to Japan, and visited the site of Osaka Main Camp and Kobe Camp (Osaka #2). The Network collaborated with the TV company.
- 2005/12/? The Network prepared a collection of the Japanese high school students' impressions on the get-together meeting they had had with Cheney High School students from the UK in August this year.

- 2006/1/? A former American POW, Mr. Everett Reamer and bereaved family members of a former American POW, Mrs. Nancy Brown and her child came to Japan, and visited the sites of Osaka Main Camp, Tanagawa Camp (Osaka #4), Sakai Prison, and the Commonwealth Cemetery in Yokohama.
- 2006/2/5 Study Meeting: Mr. Norio Suzuki, son of Col. Kunji Suzuki, the Commander of Omori (Tokyo Main) Camp, lectured on his father's Sugamo Prison Diary.
- 2006/3/5 Study Meeting: Mr. Kan Sugahara, an honorary Network member, lectured on the Japanese Navy and the Naval Academy.
- 2006/4/2 Study Meeting: Mrs. Mayumi Komiya, a Network member, reported on the Civilian Internment Camps within the country.
- 2006/5/14 Study Meeting: Mr. Yuji Miwa, a Network member, reported on the modernization of Japan, and her merchant men.
- 2006/5/30 Network members Mmes. Yoshiko Tamura and Taeko Sasamoto were awarded the MBE (Member of the Order of the British Empire) by the Queen of the UK. An award ceremony was held at the British Embassy in Tokyo.
- 2006/5/28-6/8 Former British POWs, Mr. Frank Planton and his family visited Japan. After attending the award ceremony for Mmes. Tamura and Sasamoto, they visited the Commonwealth Cemetery in Yokohama, and the sites of Kamaishi Camp (Seidai #5, Iwate Pref.), Ohashi Camp (Sendai #4, the same), and Hakodate Main Camp in Hakodate, Hokkaido.
- 2006/6/7 The artist Kiichiro Ueda, thru the intermediation of the Network members Mr. Miwa and Mrs. Ibuki, presented a painting of the Oryoku Maru to the Hellship Museum in Subic Bay, the Philippines.
- 2006/7/17 Study Meeting: After showing a documentary "Itsuwari no Bohyo - False grave markers," Mr. Isamu Fukuda, a survivor of the Cowra incident, and Ms. Sayuri Kigawa, daughter of the 3rd President of the Cowra Association, lectured on the Mass breakout of the Japanese at Cowra.

2006/8/22-23 A seminar titled “Towards a Better Understanding, Reflections on the Experiences of Australian Prisoners of the Japanese” was held at the Australian National University in Canberra, Australia, under the joint sponsorship of the Division of Pacific and Asian History, Research School of Pacific and Asian Studies and the Network. Emeritus Prof. Hank Nelson, Australian researchers, former POWs, and Network members delivered a speech, respectively. During the two-day seminar, a total of approx. 100 people, including 13 Network members, attended the seminar. Thereafter, the Network members visited the Australian War Memorial and Cowra Town, where the Japanese POW Camp once located. They also visited former POWs, internees, and their bereaved families in various places in Australia.

- 2007/2/8 Mr. Miwa, a Network member, published a book “Umi no Bohyo, Senjika ni ushinawareta Nihon no Shosen – Grave markers at sea, the Japanese merchant men lost during the war.”
- 2007/4/1 Mr. Ian Topham, son of a former British POW Mr. Stanley Topham, came to Japan with his children. They visited the Commonwealth Cemetery in Yokohama, Ysukuni Shrine in Tokyo, the site of Mitsushima Camp (Tokyo #12, Nagano Pref.)
- 2007/4/28 The Network drew up “The Australian Seminar Reports.”
- 2007/5/19 Approx. 20 people, including some Network members, visited the site of Ofuna IJN POW Camp and Ryuhoji Temple in Ueki, Kamakura City, in advance of the seminar on the following day.
- 2007/5/20 The Network conducted an “International Seminar related to the B-29s” at Eiko Gakuen in Kamakura City. The speakers were Assoc. Prof. Thomas Saylor, Concordia Univ., Mr. Hisashi Tezuka, a member of the Group to record the air raids against Yokohama, and the following Network members: Prof. Gregory Hadley, Niigata Univ. of International and Information Studies, Mrs. Nori Nagasawa, Messrs. Toru Fukubayashi, Ichiro Hisano, and Koichi Hiramatsu. Approx. 70 people attended the seminar.
- 2007/7/1-9 Daughter of a former British POW, Mr. James R. Butterworth who had deceased in Hakodate, came to Japan with her whole family, and visited Hakodate and the Commonwealth Cemetery in Yokohama.
- 2007/9/3-9 Former Australian POWs, Mr. David Barrett (Thai-Burma Railway) and Mr. Bill Flowers (Changi Camp) delivered a speech at the seminar in Canberra, Australia, in the summer of 2008, came to Japan with their sons. They visited the Commonwealth Cemetery in Yokohama, and Ryozan Kannon. Some Network members dined together with them to celebrate the reunion in Tokyo.
- 2007/10/10 Prof. Gregory Hadley, a member of the Network, published a book on a B-29 crash incident in Niigata entitled “Field of Spears The last mission of the Jordan crew.” He delivered a speech at the Foreign Correspondents’ Club of Japan in Tokyo.
- 2007/10/13 The Network held a seminar at Osaka Univ. of Economics and Law in Tokyo. The lecturers were as follows (all Network members).
 “The Asia and Pacific War, and the Japanese Military’s POW policies” by Prof. Aiko Utsumi, “Aircraft POWs air raided the Japanese mainland” by Mr. Toru Fukubayashi, and “Allied POWs as viewed from the Commonwealth Cemetery based on the analysis of the death roll” by Mrs. Taeko Sasamoto.
 The Network was designated as the approved study group of the Asian Pacific Study Center of the Osaka Univ. of Economics and Law headed by Prof. Kinhide Mushakoji.

- 2007/10/20 Study Meeting by visiting speakers: Prof. Kenji Takizawa of Hakuo Univ. and his spouse, Prof. Karen Takizawa of Hosei Univ. lectured on their joint work “Four GI spoons full of rice grains, the Pacific War talked about by our grandfather.”
- 2007/10/20-25 Mr. Ray “Hap” Halloran, a former B-29 navigator and POW, visited Japan to make an appearance on a TBS (Tokyo Broadcasting System) program.
- 2007/12/1 Study Meeting: Mr. Hisashi Tezuka, a Network member, reported on the Battle of Wake Island.
- 2007/12/? Mr. Shinetsu Okita, a Network member, published a book “Shokuminchi Jidai no Furu-honya tachi, Karafuto, Chosen, Taiwan, Manshu, Chukaminkoku, Kuhaku no Shominshi – Secondhand bookstores during the colonial period in Sakhalin, Korea, Taiwan, Manchuria, and China, a blank space in the common people’s history.

- 2008/1/20 Study Meeting: Mrs. Fuyuko Nishisato, a Network member, reported on Mukden Camp in Manchuria.
- 2008/3/15 Study Meeting: Ms. Naoko Jin, a Network member, reported on her planned work named “Bridge for Peace, a project to tie the Philippines and Japan via video messages.”
- 2008/4/15 Mr. Ray “Hap” Halloran, a former B-29 navigator and POW, delivered a speech at the Foreign Correspondents’ Club of Japan in Tokyo.
- 2008/4/23-28 Son of a former British POW, Mr. Ian Prichard came to Japan, and visited the site of Innoshia Camp (Hiroshima #5, Hiroshima Pref.).
- 2008/4/26 Study Meeting: Mr. Hisashi Tezuka, a Network member, introduced a book “Late summer of 1941 and my war with Japan” by Welden Hamilton, a former POW of Bataan.
- 2008/5/24 Prof. Gregory Hadley, a Network member, delivered a speech on “Violence of common people in wartime, B-29s and bamboo spears” at the Nihon Kyoiku Kaikan in Tokyo, sponsored by the Shimin Bunka Forum.
- 2008/5/31 Dr. Lester Tenney, a former American POW and author of “My hitch in hell, the Bataan Death March,” delivered a speech at the Kyoto Heart Pier in Kyoto.
- 2008/6/4 The members of the “US-Japan Dialogs on POWs” held a meeting with Dr. and Mrs. Tenney at the Seiryō Kaikan in Tokyo. Some interested Network members attended the meeting.
- 2008/6/7-8 The 6th Annual Meeting of the Network was held in Fukushima City. Lectures and field trips regarding Fukushima Internment Camp were as follows (except for Mr. Shigeru Konno, the lecturers are the Network members).
 “Fukushima Internment Camp and the 509th Composite Group (the US AAF Unit dropped the A-bombs)” by Mr. Konno, Fukushima Mimpo Editorial writer,
 “Detention of the enemy aliens during the Pacific War” by Mrs. Mayumi Komiya.
 “Fukushima Internment Camp, lifting the shroud of silence” by Prof. Robert Murphy.
 The participants visited the old Norte Dame Convent (the former internment camp), internees’ graveyard in Shinobu yama, and Zuiryūji Temple, where a large iron piece (approx. 20cm x 50 cm x 3 cm) of a pumpkin bomb (used for testing and training of the 509th Composite Group) had been kept.
- 2008/9/27 Study Meeting: A lecture was given by an Australian naval historian, Mr. Ian Pfenningworth on Following the footsteps of Dr. Stening, an Australian POW.”

- 2008/10/25 A Network members, Mr. Takeshi Sawada reported on “The truth about Chichi Jima incident, Testimony of a certain Ensign witnessed the execution of an American POW. Mr. Hisashi Tezuka on “Movements of the POWs regarding the missing Pekin man’s fossil, and the POW Camps in the Japanese occupied areas at the early stage of the War.”
- 2008/10/28 Daughters of a former British POW, Ms. Paula and Judith Medcalf visited Japan to call round at the site of Mukaishima Camp (Hiroshima #4), where their father was detained.
- 2008/11/13 At the Diplomatic and Defense Committee of the House of Councilors, MP Yukihiisa Fujita, a member of the Democratic Party of Japan, questioned the Prime Minister Taro Aso and the Foreign Minister Hirobumi Nakasone about the POWs’ hard labor at Aso Coal Mine by showing a copy of the “Report on Aso Mining Company,” found in the NARA, and forwarded to MP Fujita by a Network member, Mr. Toru Fukubayashi.
- 2008/11/29 Study Meeting: A Network member, Prof. Aiko Utsumi, reported on “The war criminal trials and the POW issues.”

<2009>

- 2009/1/24 Study Meeting: Prof. Aiko Utsumi, Mmes. Yoshiko Tamura and Fuyuko Nishisato, and Mr. Toru Fukubayashi talked about Aso Mining Company’s employing the POWs in WWII.
- 2009/1/29–2/8 Mrs. Pattie Wright, an Australian writer, visited Japan and, with the help of the Network, interviewed, the people involved in the construction of the Burma–Thailand Railway. March-June, 2020 Due to the spread of new Corona virus infection, beginning with the temporary closure of elementary, junior high and high schools in the country all at once as from 28 February, the Government announced a state of Emergency from 7 April to 24 May for the Tokyo Area. This prohibited us from holding various meetings, visiting local areas and overs, nor receiving visitors from overseas. Thus, the circumstances under the state of emergency have cast a long shadow over our Network activities.
